THE PUNJAB MAINTENANCE OF PUBLIC ORDER (AMENDMENT) ORDINANCE 2017

(XII OF 2017)

AN ORDINANCE

to amend the Punjab Maintenance of Public Order Ordinance, 1960.

It is necessary further to amend the Punjab Maintenance of Public Order Ordinance, 1960 (XXXI of 1960) to harmonise it with the local government system envisaged under the Punjab Local Government Act 2013 (XVIII of 2013).


Provincial Assembly of the Punjab is not in session and Governor of the Punjab is satisfied that circumstances exist which render it necessary to take immediate action.

In exercise of the powers conferred under clause (1) of Article 128 of the Constitution of Islamic Republic of Pakiston, Governor of the Punjab is pleased to make and promulgate the following Ordinance:

1. Short title and commencement - (1) This Ordinance may be cited as the Punjab Maintenance of Public Order (Arrendment) Ordinance 2017.

(2) "It shall come into force at once."

Whereas it appears to the Commissioner, Rawalpindi Division Rawalpindi, that the land (hereinafter referred to as said land) specified in the notification under section-4 f the land Acquisition Act-1894 has been issued by the District Collector Rawalpindi vide his No.LAC/DC/309 dated 06-12-2016 and published in the Punjab Official Gazette on 16-12-2016 is required to be taken by the Government at the public expenses for a public purpose namely Comprehensive Water Supply Scheme for Dhoke Chaudrian, Morgah, Kotha Kalan, Neighbouring Colonies, Distr Rawalpindi (Acquisition of Land for Construction of Ground Storage Tank (GST-400000 GLNS).

- 2- And whereas, the Commissioner Rawalpindi Division Rawalpindi is satisfied that the land specified below is urgently required the provision of Sub section (i) of section-17 of the Land Acquisition Act, 1894 are applicable to the aforesaid land.
- Now therefore, in exercise of powers under sub-section (4) of section 17, of the said act the Commissioner Rawalpindi Division Rawalpindi, is further pleased to direct that the provision of section 5 and 5-A of the act shall not be applicable in the case of said land and that the Land Acquisition Collector, Rawalpindi Development Authority Rawalpindi should take action accordingly.
- A declaration is also made under the prevision of section 6 of the Land Acquisition Act 1894 to all whom it may concern and under the prevision of section 7 of the said act. Land acquisition Collector, Rawalpindi Development Rawalpindi is hereby directed to take order for the acquisition of land.

Or a municipal corporation as defied in section-1 (ii) or a development or other public authority. company or corporation (Whether autonomous; semi autonomous owed or controlled by Govt, or a municipal body as defined in section-2 (ii) of the Punjab Development of Cities Act-1974, who have any objection to the acquisition of any land / structure described below within thirty days of the publication of this Notification file objection in writing before the Land Acquisition Collector.
